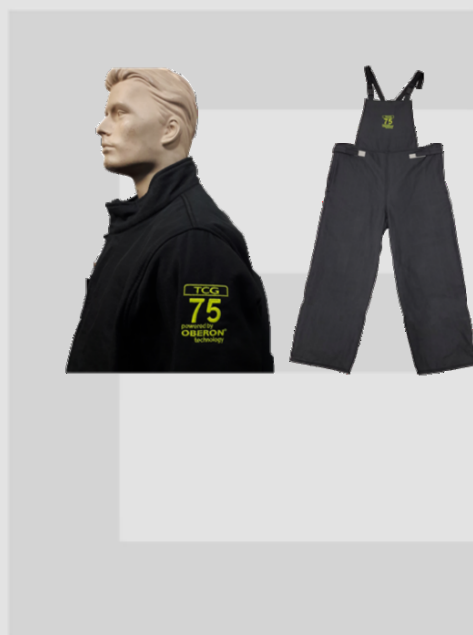

Description of the PPE:

Jacket and trouser set made in black woven fabric, yellow non-woven and a lining made in yellow woven fabric. Jacket has plastic zip with metal pull, covered by a flap fastened with self-fastening tape at the central closure. The trouser bottoms adjust with a strip of fabric and self-fastening tape. Waistband has a bib. It fastens with suspenders and plastic buckles. The waistband adjusts with a strip of fabric and self-fastening tape at the sides.

The materials that form the PPE, are described in the conformity assessment report n° 2021US0071UE.

The PPE is available with the following variants:

- The PPE can be presented as a set variant, with the same design and the same composition and weight as the main one, but with the addition of logos, with reference TCG75.

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
