Description of the PPE:

Hood with protective face shield supported by a helmet. The hood is composed by outer woven fabric, black colour + five-layer intermediate non-woven fabric, yellow colour + lining of woven fabric, yellow colour. The hood presents in its front part an embroidery where it is written: TCG 100 Powered by OBERON® technology. On the back, it has a circular opening covered internally by the same fabric that forms the hood and a yellow and grey strip joined horizontally. It presents an external strap in the front side and an external strap in the upper side. The face shield is an eye protector that in addition to protecting the eyes completely covers the face providing a wider protection. The face shield is used coupled to a safety helmet, as a coupling device, through a support.

The materials that form the PPE, are described in the conformity assessment report no 2021EC0480UE.

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.

The CAT. III PPE shall only be used in conjunction with one of the conformity assessment procedures according to module C2 or module D described in article 19 letter c) of the Regulation (EU) 2016/425.
